Introduction

Collection of Personal Information

Apex Recruitment Services collects various categories of Personal Information and has a legitimate interest in processing personal data during the recruitment process (and for keeping records of that process). If you submit a request via this website or through email communication, we may collect your name, email address, or other Personal Information contained within that correspondence. If you are an applicant or a candidate we may collect your name and contact details along with information about your employment history, professional experience and qualifications, educational qualifications, language ability or any other data you may provide online through a web based application form or your personal CV.

If you are a client or potential client we may collect your name, contact details, title or position, products or services requested, or other information that you may provide online through a web-based application form or email correspondence.

With regard to all website visitors, we do not wish to collect any 'sensitive' Personal Information such as racial or ethnic origin, age, political, religious or philosophical beliefs, sexual life, social security or other Government identification numbers, Trades Union membership health or medical conditions, or criminal history unless legally required for recruitment purposes.

Use of Personal Information

We may use Personal Information to respond to your enquiries and answer your questions, to provide you with requested information, and to undertake activities in connection with the conduct and management of our assignments. Examples include (but are not limited to) evaluating candidate qualifications, contacting potential candidates for further Personal Information, contacting named references, and communicating with clients about potential candidates. Apex Recruitment Services may also use Personal Information for the purpose of testing and maintaining our company databases, networks and computer systems, and for training and other internal purposes.

Disclosure of Personal Information

We may share Personal Information with our affiliates and, where necessary or appropriate, in connection with the performance of our services to you and our clients. Our clients may be located in jurisdictions around the world.

We reserve the right to disclose Personal Information to third party subcontractors including information technology providers and business process outsourcing providers, in order to support our continuing operations. We also reserve the right to disclose Personal Information in connection with any sale, assignment or other transfer of all or part of the business, or where we believe such disclosure may be required by law or may be necessary in connection with any legal claims. We may also use, disclose or otherwise process information you provide for statistical or other purposes we choose in our sole discretion, as long as such information is not in a personally identifiable form.
